

# Penn State Tech + Web Pros Conference

### Date and Time

#### Tech+ Web Pros

The Sponsor Showcase for The Pennsylvania State University's Penn State Tech + Web Pros Conference will be held **Wednesday - Friday, June 4 - 6, 2025**, at Penn State Brandywine (specific location TBD). You may set up your table anytime the morning of Wednesday, June 4, starting at 9 AM. Attendees will pass through the sponsor area as they register for the event and attend sessions for the conference in the afternoon, but expect the most activity right before and during the lunch hour. Sponsors are welcome to stay as late as 6 PM on Wednesday. The main bulk of the conference will take place on the second day, Thursday, June 5, and sponsors should plan to be there from 8 AM until 5 PM. Attendees will pass through as they register for the event and throughout the day between sessions. The peak times will occur first thing in the morning, then during and after lunch. At no additional cost, sponsors may attend their tables again on the third day, Friday, June 6, beginning at 8 AM and ending when lunch concludes at 1 PM. This is a much shorter day so you may choose not to stay.

### **2. Conference Location and Dates.**

### **3. Payment.**

If any provision or provisions of this Contract are held to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

**11. Indemnification; Limitation of Liability.**

Corporation assumes full responsibility for the acts, omissions, and conduct of its representatives, agents, and contractors and agrees to indemnify, hold harmless, and defend The Pennsylvania State University, its officers and directors, trustees, employees, and agents from and against any and all claims, losses, damages, governmental fines or penalties, and costs or expenses (including court costs, interest, and attorney fees) of any kind whatsoever arising from such acts, omissions, and conduct except to the extent that such claims, losses, and damages are the direct result of The Pennsylvania State University’s gross negligence or intentional acts.
